I am VPPR of club 3610 and have responsibility for our Aetna Speaks Up! Club website. I have not been able to successfully add new members to our website as the automatic opt-in email sent by the system when I add new members via the Membership Module in the Admin Console has not been received by the new members. I had to readd 10 new members to our website since they were deleted by the system after time ran out for Activation. In 2 days this will happen again. I am able to receive a copy of the email that the system sent so I know an email was sent however the intended recipients of the email are not receiving (I tried a test with one of the members and it is not even going to our CVS Health SPAM account). I tried logging an issue with The FreeToastHost Website Support Team but you need to set up an account with them before logging an issue. However, whenever I try to create an account with them, the Captcha validation just clocks so I am unable to create an account and therefore unable to log an issue. I don't know what else to do at this point and I really do not want to add 10 new members to our club website for a 3rd time. Any help from you would be much appreciated.
